

AURORA REWARDS 4th ANNIVERSARY SWEEPSTAKES CONTEST RULES

ARTICLE 1-SPONSOR AND PRIZE SUPPLIER

1.1 Sponsor

ARTICLE 2 – ELIGIBILITY

2.1 Residency, Eligibility & Age
